July 20, 2021

1. CALL TO ORDER AND ROLL CALL

The Transportation Advisory Committee (TAC) meeting of **Tuesday July 20, 2021** was called to order by Chair Henry Mackenroth at 6:00 PM via a virtual Zoom Meeting.

Committee members present included Ray Atkinson, Bob LaSalle, Henry Mackenroth, Savannah Ovaldia, and Ben Simmons.

Staff members present included John Lewis, Public Works Director, Dayna Webb, City Engineer, and Vance Walker, Assistant Public Works Director.

2. APPROVAL OF THE MINUTES

Mr. Simmons **moved to approve** the minutes of **June 15, 2021**, and it carried **unanimously** by the following vote: Aye: Atkinson, LaSalle, Mackenroth, Ovaldia, and Simmons.

3. AGENDA ANALYSIS

No new business items to add.

4. CITIZEN COMMENTS

No citizen comments were made.

5. NEW BUSINESS/DISCUSSION ITEM

a. ODOT I-205 Toll Project

Major points were as follows:

- Three representatives from ODOT, Lucinda Broussard, Matt Dolata, and Jennifer Rabby were in attendance to provide an update on the I-205 Tolling Project.
- Ms. Broussard said they would be talking about a better understanding of the I-205 Toll Project and upcoming work, what the key problems they should be trying to address, and how they can make it a successful and equitable tolling program.
- Ms. Broussard said that House Bill 2017, "Keep Oregon Moving", is what got this project moving.

- Ms. Broussard talked about how tolling would work and how it would be all electronic.
- Ms. Broussard said the benefits of tolling are improved travel time and increased reliability, reduced greenhouse gas emissions and fuel consumption, sustainable funding for investments, and strategies and investments to advance equity and mobility.
- Ms. Broussard said they don't know yet how much tolling will cost, but you will know the price before you get on the road.
- Ms. Broussard said tolling will pay for UMO core improvement projects, transit and multimodal transportation options, neighborhood health and safety, and people experiencing low-income.
- Ms. Broussard shared a timeline of when tolling would start. She went through the steps of the Equity Framework.
- Ms. Rabby went through the disciplinarys that will be studied for the tolling project.
- Mr. Dolata went through the details on how they are going to do the transportation analysis. He said there are three levels of this modeling.
- Mr. Dolata said the area of potential impact is where they will focus the analysis on.

b. Oregon City Connector Shuttle

Major points were as follows:

- John Lewis talked about the Clackamas County Connects Shuttle Service. Mr. Lewis shared the Clackamas County Webpage with information about the shuttle service, including the routes and the schedules.

September 21, 2021

1. CALL TO ORDER AND ROLL CALL

The Transportation Advisory Committee (TAC) meeting of **Tuesday September 21, 2021**, was called to order by Chair Henry Mackenroth at 6:00 PM via a virtual Zoom Meeting.

Committee members present included Ray Atkinson, Henry Mackenroth, and Cedomir Jesic. Bob LaSalle arrived late.

Staff members present included John Lewis, Public Works Director, and Kim Davis, Senior Administrative Assistant.

2. APPROVAL OF THE MINUTES

There was not a quorum, therefore the minutes of July, 20, 2021 were not approved.

3. AGENDA ANALYSIS

4. CITIZEN COMMENTS

Catherine Pieslewicz, a citizen of Oregon City, shared concerns about an increased volume of traffic along Molalla Avenue, specifically at the intersections of Pleasant Avenue, Mt. Hood Street, Mountain View Street, Barclay Hills Drive, and Holmes Lane.

5. NEW BUSINESS/DISCUSSION ITEM

a. Public Works Report

Major points were as follows:

- Mr. Lewis gave an update on the lights at Redland Road and Abernethy Road. He said PGE added three streetlights along Redland Road between Abernethy and Redland Road.
- Mr. Lewis gave an update on the Park Place Urbanization Plan.
- Mr. Lewis gave an update on the Vehicle Registration Fee Projects. He gave an update on the projects that are completed, the projects that are under way, and the upcoming projects.
- Mr. Lewis gave an update on city wide traffic counts. He said we've been on a three-year cycle, but 2020 traffic counts were postponed due to COVID. He

said traffic counts will resume beginning September 27th.

- Mr. Lewis said the Washington Street – I-205 wayfinding signs have been re-located and are easier to see.
- Mr. Lewis said Molalla Avenue Streetscape Project is coming to an end.
- Mr. Lewis said on September 28th, there will be an Oregon City and West Linn joint work session about what the Cities have going in terms of economic development or re-development. He said ODOT will be in attendance to give updates as well.
- Mr. Lewis said on September 30th, there will be an Oregon City and West Linn joint work session about the Oregon City/West Linn Pedestrian and Bicycle Concept Plan.

6. COMMUNICATION

- Mr. Atkinson said Parking Day is Friday.

7. FUTURE AGENDA ITEM

- No future agenda items were made.
