2. Presentations

2a. Oregon City Together: "Emerging trends in youth marijuana and alcohol use in Oregon City", Pamela Wilson (15 Minutes)

Commissioner Brian Shaw introduced Pam Wilson, OC Together Coordinator, and Paige Hirt, Vice Coordinator. Ms. Wilson explained who OC Together was, what their role is in the community, and why its important. OC Together is a local coalition with a board that has youth on it. The focus of the coalition is alcohol and drug prevention. They are grant funded through Clackamas County and the Substance Abuse and Mental Health Administration. The strategies of the group are research based, best practices, and education. They conduct surveys through the youth and parents in the community each year. They have found the parents who talk with their kids early and often and have communicated clear rules end-up having the best results. They reviewed the survey results for 2018 compared to the past couple of years. Ms. Wilson introduced the Health Futures film series they are kicking-off this week. She mentioned how folks in the community could help with the program.

Erica Tim, from Friends of Trees, shared the Friends of Trees mission statement which is, Friends of Trees empowers people to improve the natural world around them through a simple solution: Planting Trees Together. Friends of Trees is a 501c3 non-profit that started in NE Portland about 30 years ago. Friends of Trees has planted over 750,000 trees and native shrubs to date. There are two programs, Neighborhood Trees and Green Space Initiative. Friends of Trees works with Oregon City and all neighborhoods to plant trees in the community and has helped to plant around 308 trees in Oregon City. Ms. Tim discussed the upcoming Tree Planting event in Oregon City scheduled for December 1, 2018.

Ms. Robertson-Gardiner gave some background on the grievance process, how it starts with the formation of a grievance committee, they hear the grievance, go through the public hearing process, deliberate, and come up with findings. Ms. Robertson-Gardiner stated that the committee members need to re-open the public hearing and either make a decision or request more information from the Grievance Committee.

Committee Member Johnson, previous chair of the Grievance Committee, discussed two specific grievances. One was submitted against Barclay Hill Neighborhood Association Chair, Betty Mumm, and the other was submitted against Mayor Dan Holladay. Committee Member Johnson stated that their recommendation to the Citizen Involvement Committee (CIC) for the first claim against Ms. Mumm found that there was no evidence to support the claim. For the second claim, Committee Member Johnson stated that the Grievance Committee recommends that they found no fault in Mayor Dan Holladay.

Vice Chair Mitchell asked if any of the committee members had any ex parte contacts or conflicts of interest in need of disclosing.

None of the committee members had any.

Vice Chair Mitchell asked if any of the citizens in the audience had any disputes with these statements, to which there were none.

Vice Chair Mitchell opened the public hearing. There were no statements made from the applicants, representatives of the neighborhood associations, or the general public.

Vice Chair Mitchell then closed the public hearing and proceeded to ask if there were any questions for Committee Member Johnson regarding the grievances.

There was only one question regarding whether or not there were substantial changes to the original draft of the grievance document, to which Committee Member Johnson said there were none. All of the changes made were for ease of understanding such as changing the order in which the grievances are discussed in the report.
