2. Guest Speaker:

- **2a:** Mike Morton, Architect presented plans for demolition of existing building and construction of larger new building on Abernathy Rd for Royal Flush Plumbing, an apartment for the owner and a commercial space for lease. Parking will be on the first level. After discussion the CIC voted nearly unanimously, with only one abstention from Tony due to his late arrival, to send a letter of support of the plans to the Planning Division.

- Diane announced the RNA plant sale was a success, work is going forward on the bathrooms at Rivercrest Park, they are looking for a new meeting place, and they are looking to purchase liability insurance.
