ROLL CALL

Mayor McGriff presented some of the issues that the Commission Members cited in their applications to be discussed. All Youth Advisory Commission members commented on some issues that are facing the Oregon City community, particularly racial discrimination. Many commission members commented on their frustration at lack of action in response of racial comments & flyers that had been present at Oregon City High School. Education & knowledge of history were brought up as important tenents of combating this issue in the community. The idea of presenting to the school board was brought up to move forward with this issue, to be discussed in detail at a later meeting.

FUTURE

Jarrod Lyman presented some future topics that Commission Members should keep in mind for the next meeting. These topics include writing Youth Advisory Commission By-Laws, possible filming from a local news station, and how to channel ideas into a formed project for the YAC.

ADJOURNMENT

After ending the discussion, refreshments were enjoyed while Commission Members mingled. Meeting was adjourned, with the next Youth Advisory Commission meeting schedule for April 10th at 7 pm.
