A RESOLUTION ADOPTING REVISED BYLAWS FOR THE NATURAL RESOURCES COMMITTEE

WHEREAS, the Natural Resources Committee (NRC) was established by Ordinance No. 02-1013 and went into effect on September 20, 2002; and

WHEREAS, the Natural Resources Committee (NRC) bylaws were approved as Exhibit A to Resolution No. 04-29 on August 18, 2004; and

WHEREAS, the City Commission and the Natural Resources Committee desire to revise the bylaws to better reflect the Natural Resources Committee responsibilities in accordance with the City Commission Goals and Priorities; and

WHEREAS, the Natural Resources Committee has drafted procedures for a fair, efficient, and agreeable committee process.

NOW, THEREFORE, OREGON CITY RESOLVES AS FOLLOWS:

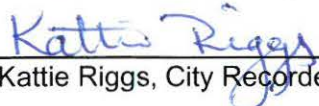
1. The City Commission hereby adopts Exhibit "A," the revised bylaws for the Natural Resources Committee.

Oregon City Natural Resources Committee Proposed Revisions to Bylaws

EXHIBIT A TO RESOLUTION NO. 15-34

Article I: Name

This committee shall be known as the Natural Resources Committee (NRC).

Article II: Authority

The Natural Resources Committee is established by Ordinance by the City Commission of Oregon City. Oregon City Municipal Code Chapter 2.56 outlines the duties and responsibilities of the NRC.

Article III: Mission Statement / Preamble

In concert with the City, the committee shall advise, evaluate, and advance an agenda that empowers citizen, business and governmental stakeholders to become natural resource stewards who achieve a beneficial balance among people and natural systems now and in the future.

Article IV: Responsibilities

1. Promote community involvement in conservation of natural resources within the City and its Urban Growth Boundary (UGB) in partnership with the City, neighborhood associations, and community organizations.
2. Initiate recommendations and review updates to the City's comprehensive plan, codes and policy as they relate to statewide Planning Goals that are integral to our mission.
3. Receive notice of and comment on land use applications and City activities that have the potential to impact natural resources in the City and its Urban Growth Boundary.
4. Conduct orderly meetings that result in good communication to city staff, policy makers, city departments and community to achieve our mission.
5. Coordinate with the Parks and Recreation Advisory Committee (PRAC) and Planning and City Commissions on at least an annual basis that results in good communication and mutually beneficial results.

Article V: Officers and Staffing

Officers: The Officers shall consist of a Chair, a Vice-Chair and a Secretary, who shall be selected by the membership and serve at the pleasure of the membership for one-year terms. Nominations and elections of new officers shall be taken from the floor at the Committee's first meeting of each calendar year. Officers may be re-elected. In the event that an Officer is unable to complete the specified term, a special election shall be held for the completion of the term.

1. Chair: The Chair shall have general supervisory and directional powers over the Committee. The Chair shall preside at Committee meetings and develop agendas with the staff liaison. The Chair shall be the designated spokesperson for the Committee unless this responsibility is delegated to another party. The Chair shall be an ex-officio member of all subcommittees.
2. Vice-Chair: In the absence of the Chair, the Vice-Chair shall have general supervisory and directional powers over the Committee, preside at Committee meetings, develop Committee agendas with the staff liaison, and generally conduct all business delegated to the Chair.
3. Secretary: The Secretary shall review transcribed minutes for each of the regular meetings and worksessions. The Secretary shall provide staff with the signed minutes for staff's retention of the public record. Additionally, the Secretary shall provide staff with an electronic version of the minutes for posting on the City's web site.

Staff: The City of Oregon City will provide staff support to the Committee for meeting notification, word processing, copying and information gathering to the extent the City budget permits.

Article VI: Organizational Procedures

1. All meetings will be conducted in accordance with the latest revised edition of Robert's Rules of Order.
2. A majority of the Committee members must be present either in person, via telephone, or internet at a meeting in order to form a quorum and act on motions, or otherwise take a position on issues. Meetings can be held without a quorum, but issues can only be discussed, not acted upon, and no motions can be made or acted upon. All members should make every effort to be physically present at the meetings.
3. Committee discussion will occur ahead of any vote following Roberts Rules of Order. The main function of the chair in this process is to serve the group by managing the process of building consensus. During this process, the Chair's job

- is to articulate the themes of agreement as well as address differences and conflicts.
4. When a vote is called for and a quorum is present, a majority affirmative vote of those present at the meeting is required, except that a two-thirds majority vote is required for changes or amendments to the Bylaws, as outlined in item 7.
 5. Minutes will be approved by majority vote of the members present at a scheduled meeting where a quorum is present.
 6. Before the end of each calendar year, the committee will review and assess outcomes and activities during the year. At that time, the committee will prioritize their goals and responsibilities for the following year. These goals and responsibilities will be submitted to the Oregon City Commissioners and the Oregon City Parks and Recreation Committee for their consideration and use during annual planning retreats.
 7. The following process shall be followed in order to make changes or amendments to the Committee Bylaws. Changes or amendments will be proposed and discussed at a scheduled NRC meeting. Voting will take place at the next scheduled NRC meeting. A two-thirds vote of an NRC quorum present at the meeting is necessary for approval of the proposed changes or amendments. The proposed changes or amendments will be forwarded to the City Commission for approval.

Article VII: Subcommittees

NRC subcommittees will be established as needed. The purpose of the subcommittees is to delegate work to several members on the NRC, who will be responsible for special projects and concerns as related to natural resources. Subcommittees may also involve non-NRC members, where appropriate. The subcommittees shall report to the NRC for direction. Subcommittees will be Standing Subcommittees or Ad Hoc Subcommittees, as appropriate.

When other Standing Subcommittees are formed, subcommittee names and scope of activities shall be determined by a majority vote of NRC members present at a scheduled meeting where a quorum is present and shall be reported in the appropriate meeting Minutes.

Ad Hoc Subcommittees can be established by consensus of the members present at a scheduled meeting.

Article VIII: Code of Conduct

It is the intent of the NRC to be a committee in good standing with the community. As such, the members of the NRC shall:

1. Work for the common good of the City within the City Commission framework.
2. Give respect and dignity to all committee members, staff, and citizens, regardless of personal opinion or bias.
3. Learn from the past and focus on the present and future in making wise decisions.
4. Take no action on the Committee's behalf without following proper procedures. Appropriate actions shall comply with the City's Comprehensive Plan and implementing ordinances, the City Code, and with the NRC Bylaws.
5. Any NRC member who feels that there is a potential conflict of interest between his/her professional or personal activities and the issue under discussion will recuse herself/himself from any vote that may be taken on the issue.
6. An NRC member in good standing shall attempt to attend all meetings either in person, or via telephone or internet. If unable to attend, the member shall notify the chair, and the city staff liaison. If a member fails to notify the chair or city staff liaison prior to missing a meeting, or if a member misses two consecutive meetings, or three meetings in a calendar year, the chair will contact the committee member. The remainder of the committee will then consider a recommendation concerning continued membership.

Appendix A: Tree Subcommittee Scope of Activities

1. Study, investigate, develop, and submit a written tree plan for the care, preservation, pruning, planting, replanting, removal, or disposition of trees in parks, and in public areas, which includes the public right-of-way. The tree plan will be reviewed by the NRC prior to submittal to the City Commission for approval.
2. Review and recommend regulations for tree pruning and maintenance by utility companies operating in Oregon City.
3. Review the City's adopted street tree list on a regular basis and recommend changes as necessary.
4. Promote the planting, proper maintenance, and conservation of trees throughout Oregon City.
5. Develop standards for identifying and designating heritage trees on public and private land within Oregon City.

- a. The Tree Subcommittee shall prepare a list of criteria to be used for determining when a tree qualifies for designation as a heritage tree. Criteria may include age, size, species, notability, or historical association.
 - b. The Tree Subcommittee shall review a heritage tree nomination by a citizen or the subcommittee itself.
 - c. The Tree Subcommittee shall make a recommendation on heritage tree designation.
 - d. The Tree Subcommittee shall plan for appropriately-placed plaques for designated heritage trees, and shall make recommendations for tree maintenance.
 - e. A list of heritage trees shall be available at City Hall for inspection by the public upon request.
6. Develop an Oregon City Tree Ordinance.
7. The City of Oregon City may accept gifts, which are specifically designated for the purpose of planting or maintaining trees within the city. A separate fund shall be established and maintained for revenues and expenditures created by activities specified here. The Tree Subcommittee, working through the NRC, shall have authority to seek grants and alternative funding for tree projects (e.g., Tree City USA designation).

STAFF RECOMMENDATION:

BACKGROUND:

1. NRC work plan topics.

The updated work plan for 2023-2025 consist of projects and tasks for the 2023-2025 biennium.

2. City Commission Goal 7 - Protect and preserve our environmental and natural resources for a healthy, sustainable community; 7.1 Focus efforts on preserving and protecting the City's Tree Canopy

Staff will provide an update on Friends of Trees pruning and planting events in Oregon City, tree inventory work, and our recent TCUSA application details.

3. Tree Code Recommendation to the City Commission

NRC members have expressed concerns that the Street Tree Code needs to be re-examined to better protect trees. NRC will discuss a draft written recommendation to the City Commission explaining their concerns and requesting that the City Commission consider the recommendation.

At the January 10, 2024 meeting, Assistant City Engineer Josh Wheeler gave a presentation on the City's sidewalk repair program. Planning Manager Pete Walter provided a summary of various Metro area municipal tree permit programs and fees.

4. Format for future NRC Meetings

Committee members have discussed moving back to in-person meetings in stead of Zoom. The CIC and several other boards and committees have already done this. Meetings would continue to be available to the public to participate on-line and would continue to be streamed on WFTV and the City's YouTube Channel.

Oregon City Natural Resources Committee 2023-2025 Work Plan

NRC Responsibility #1:

Promote Community Involvement in Natural Resources Conservation

1. Support a public tree inventory with volunteer participation for city properties, parks, street trees, school properties and other public lands.
2. Communicate regularly with Neighborhood Associations, Citizen Involvement Committee and the business community to promote programs such as the heritage tree program and arbor day.
3. Improve awareness through the city website, brochures, QR code signage, and social media for awareness and interpretation of local natural and geological features, trails, stormwater facilities, watersheds and sites. Coordinate with city efforts to enhance tourism. This would emphasize local knowledge and provide interpretative signs for people to learn about things like birding, swift migrations, heritage trees, etc. We can use laminated signs that lead to the Oregon City website. Give people an easy way to learn.
4. Continue to strengthen and encourage participation in the Heritage Tree Program through brochures, Informational signs for trees, \$\$\$ for incentives, site visits, further outreach and social media.
5. Work with property owners to voluntarily seek heritage tree designation within the Thimble Creek Concept Plan area.
6. Support city partnerships with Home Owner Associations (HOAs), Metro and Greater Oregon City Watershed Council, Oregon City Parks Foundation and other groups for habitat improvement projects within the Urban Growth Boundary.
7. Support partnerships with Oregon Heritage Tree Council and Oregon Community Trees.

NRC Responsibility #2:

Initiate recommendations and review updates to the City's comprehensive plan, codes and policy as they relate to statewide Planning Goals that are integral to our mission.

1. Provide input to the City Commission on amendments to the City's tree protection and removal codes.
2. Support a coordinated strategy for invasive species management, such as encouraging City participation in the Clackamas County Integrated Pest Management (IPM) program. Look at the City of Eugene Integrated Pest Management (IPM) program model as an example of a way to integrate IPM into city operations.
3. Improve public outreach and information about invasive plants.
4. Amend city resolution nuisance and native plant lists to reference regionally accepted and regularly updated plant lists from Clackamas Soil and Water District, Metro, Portland, and Willamette Native Plant List.
5. With the Public Works department, explore feasibility of offering reduced stormwater rates in return for planting trees in the right-of-way to intercept rainfall, reduce run-off and improve stormwater quality.
6. Support the City's application to and participation in the Bee City USA program through the Xerces Society for Invertebrate Conservation.

7. Promote public awareness of ways to promote and preserve invertebrate habitat through educational events such as booths at a Spring Resource Fair, the city website, Trail News, the city Facebook page and other social media.
8. Promote public awareness of the dangers of pesticide use, and cost savings associated with reduced pesticide application and reduced landscape maintenance.

NRC Responsibility #3:

Receive Notice and Comment on Land Use Applications and Projects within City Limits and the Urban Growth Boundary

1. Review and comment on Type III applications to vary from the adopted standards of the Natural Resources Overlay District, Flood Management Overlay District, and the Willamette River Greenway Overlay District.

NRC Responsibility #4: Conduct Orderly Meetings that result in Good Communications

1. Maintain and Update a list of Natural Resources Committee priorities and activities to share with Planning Commission and City Commission.

NRC Responsibility #5:

Coordinate with the Parks and Recreation Advisory Committee (PRAC) and Planning and City Commissions on at least an annual basis that results in good communication and mutually beneficial results.

1. Strengthen coordination with PRAC and parks staff through regular interaction and attendance at PRAC meetings.
2. Support funding initiatives and grant applications for parks and open space.
3. Invite Parks staff to attend NRC meetings.

Standard 2 - A Community Tree Ordinance

Our Attached Ordinance

Is in effect 24/7/365
 Addresses, at the very least, all public trees in our community

12.08.030 - Public property tree maintenance. The city shall have the right to plant, prune, maintain and remove trees, plants and shrubs in all public rights-of-way and public grounds, as may be necessary to ensure public safety or to preserve and enhance the symmetry or other desirable characteristics of such public areas. The public works department and parks and recreation department may recommend to the community development director the removal of any tree or part thereof which is in an unsafe condition or may be injurious to above or below-ground public utilities, structures or other public improvements. Removed trees shall be replaced in accordance with this chapter or the mitigation requirements of the OCMC 17.49, Natural Resources Overlay District (NROD), if the tree to be removed is within the NROD.

Copy and paste relevant language from your community's uploaded ordinance addressing clear guidance over public trees in the box below.

12.08.015 Street tree selection, planting and maintenance requirements. All development shall provide

street trees adjacent to all street frontages. Species and locations of trees shall be selected based upon vision clearance requirements, but shall in all cases be selected from the Oregon City Street Tree List, an approved street tree list for a jurisdiction in the Metropolitan region, or be approved by a certified arborist unless otherwise approved pursuant to this section. If a setback sidewalk has already been constructed or the public works department determines that the forthcoming street design shall include a setback sidewalk, then all street trees shall be installed with a planting strip or within tree wells. If existing street design includes a curb-tight sidewalk, then all street trees shall be placed according to OCMC 12.08.035.C. A. One street tree shall be planted for every thirty-five feet of property frontage. The tree spacing shall be evenly distributed throughout the total development frontage to meet the clearance distances required in subsection B below. The community development director may approve an alternative street tree plan, or accept fee-in-lieu of planting pursuant to OCMC 12.08.035, if site or other constraints prevent meeting the required total number of tree plantings. B. The following clearance distances shall be maintained when planting trees: 1. Fifteen feet from streetlights; 2. Five feet from fire hydrants; 3. Twenty feet from intersections; 4. Five feet from all public utilities (i.e. sewer, storm and water lines, utility meters, etc.). C. All street trees planted in conjunction with development shall be a minimum of two inches in caliper at six inches above the root crown and installed to city specifications. Larger caliper size trees may be approved if recommended by a certified arborist or registered landscape architect. D. All established trees shall be pruned tight to the trunk to a height that provides adequate clearance for street cleaning equipment and ensures ADA complaint clearance for pedestrians. E. All trees planted within the right-of-way shall be planted with root barriers at least eighteen inches in depth adjacent to the sidewalk and curb to ensure proper root growth and reduce potential damage to sidewalks, curbs and gutters. F. All trees planted beneath powerlines shall be selected based on what is appropriate for the location. In addition, the tree species shall be approved by the associated franchise powerline utility company. G. Tree species, spacing and selection for stormwater facilities in the public right-of-way and in storm water facilities shall conform to requirements of OCMC 13.12 and the adopted stormwater and grading design standards and be approved by the city engineer. H. Any public or street trees planted within the natural resource overlay district shall conform to the applicable requirements of OCMC 17.49, Natural Resources Overlay District (NROD). (Ord. No. 18-1009, § 1(Exh. A), 7-3-2019) 12.08.025 General tree maintenance. Abutting property owners shall be responsible for the maintenance and replacement of street trees and planting strips. Topping of trees is prohibited, unless under recommendation of a certified arborist, or other qualified professional. Trees shall be trimmed appropriately. Maintenance shall include watering during dry periods, trimming of established trees to remove dead branches and dangerous limbs and to maintain a minimum seven-foot clearance above all sidewalks, eight-foot clearance in clear vision areas pursuant to OCMC 10.32, and ten-foot clearance above the street. Planter strips shall be kept clear of weeds, obstructing vegetation and trash. (Ord. No. 18-1009, § 1(Exh. A), 7-3-2019) 12.08.035 Tree removal and replacement.

The City amended subsection 12.08.035 Tree Removal and Replacement. The amended code further clarifies the tree replacement requirements for abutting homeowners. Specifically, the amendment require replanting within the planter strip as a priority unless the applicant can show clearly that there is insufficient space to replant a tree. Paying a fee-in-lieu of planting is now a last resort, with the alternatives being: a. Within the right-of-way abutting another property, with abutting property owner approval, or b. On public property, with City Manager or designee approval, or c. Within 10 feet of the right of way in the abutting private yard. Exceptions are granted for planter strips that are 3' feet or less in width. We anticipate that this amendment will help assure that "the right tree is planted in the right place."

Oregon City continues it's partnership with Friends of Trees to assist homeowners in planting and maintaining high quality trees throughout Oregon City. The program is supported through the City's Tree Mitigation fund and has resulted in approximately 800 new street and yard trees being planted throughout the City since 2013. 2023 saw another good year of replanting, expanding into northern and southern parts of the city and helping mitigate for the extensive tree canopy damage following the damaging ice storm and heat dome weather events in 2020-2022.

E16. Tree Festival: 4 pts

Describe festival and how trees were a central theme

Oregon City held a dedication ceremony to honor it's newly planted Hiroshima Peace Tree featured a reading from Oregon's Poet Laureate and the mayor announcing her support for creating an official city forester position. The original ceremony had been planned for 2020 but was postponed due to COVID-109 restrictions. To mark the 75th anniversary of the close of World War II, people in 30 communities around Oregon committed to plant about 45 special peace trees in 2019 and 2020. The young trees were grown from seeds of trees that miraculously survived the atom bombing of Hiroshima on Aug. 6, 1945. Today, Oregon has one of the largest collections of Hiroshima peace trees of any state or nation outside Japan.

**Goal 7 Protect and preserve our environmental and natural resources for a healthy, sustainable community;
7.1 Focus efforts on preserving and protecting the City's Tree Canopy**

IMPORTANT OR RELEVANT DATES/MILESTONES: (LOOKING AHEAD AT THE NEXT 3 MONTHS)

- Friends of Trees (FOT) is proposing to conduct community planting events between the months of October 2023 and April 2024. The first planting event is December 2, 2023. The next event will be on April 6, 2024.
- The focus of FOT work over the next two years is to increase canopy coverage in the right-of-way and private yards

STATUS: (WHAT HAS BEEN DONE/IS BEING DONE)

The City's contract with Friends of Trees helps to preserve and protect the City's tree canopy by offering education and volunteer events.

- A pruning workshop is tentatively scheduled for October 14, 2023
- Also tentatively scheduled is a Friends of Trees volunteer planting event on November 4, 2023.

October 11, 2023:

- The Natural Resource Committee will discuss the initiation of a program to identify Ash Trees in City right-of-way or on City owned property. The purpose of this inventory is to devise a strategy in case the pest Emerald Ash Borer lands in Oregon City and begins to kill City trees.
- Staff has begun researching and collecting data to help facilitate this volunteer effort and will present the information to the NRC at their October meeting.
- The Natural Resource Committee identified several activities in their work plan that support a healthy tree canopy:
 - *Support and promote volunteer participation for a public tree inventory for city properties, parks, street trees, school properties and other public lands.*
 - *Communicate with Neighborhood Associations, Citizen Involvement Commission and the Business Community. NRC members will promote programs such as the heritage tree program, arbor day, etc. through presentations to other groups and boards.*
 - *Community Development staff will continue to support the NRC and their efforts as a means to achieve the Commission's goal.*
