- **2a:** Kerry Ayres-Palanuk and Coral Egnew from Tri-Met presented information regarding the Portland-Milwaukie Light Rail plan and informed us of an upcoming SE Service Enhancement Plan that will be looking at the long term vision of the entire SE quadrant of the Tri-Met district. Tri-Met has added additional services to the 33 bus route and in Sept will be making capacity and reliability improvements to additional routes.
- **2b:** Tony Konkol gave an update on the WFLP Master Plan.
