EXECUTIVE SUMMARY:

Planning Commission serves as an advisory body to, and a resource for, the City Commission in land use materials. The commission is composed of seven members who serve for a four-year term and are appointed by the Mayor. The Planning Commission will be conducting interviews to fill a vacancy for a term ending December 31, 2024.

BACKGROUND:

Planning Commission serves as an advisory body to, and a resource for, the City Commission in land use materials. The commission is composed of seven members who serve for a four-year term and are appointed by the Mayor. The Planning Commission currently has one vacancy for a term ending December 31, 2024.

According to OCMC Chapter 2.24.020(C), members cannot serve for more than eight consecutive years. No more than two voting members of the Commission shall be non-residents, no more than two members shall be engaged principally or involved in any aspect of the real estate field, and no more than two members shall be engaged in the same kind of business, trade or profession. (OCMC 2.24.030).
